OWNERSHIP:

- The Chromebook and related equipment remain the property of Box Elder School District and retains the sole right of possession of the Chromebook and related equipment. Box Elder School District retains the right to collect and/or inspect the Chromebook at any time and to alter, add, or delete installed software or hardware. The Chromebook will generally be collected when school resumes for inventory and maintenance purposes.

LOSS OR DAMAGE TO THE CHROMEBOOK:

- Students must report damage or loss of the Chromebook to their school.
- If the Chromebook is lost or stolen, the student must pay a loss fee of \$250. ____ (PARENT INITIAL)
- If a Chromebook is damaged due to abuse or neglect, the student must pay a damage fee of \$60 for a broken screen, \$40 for a missing key or broken keyboard, \$50 for a broken trackpad, \$60 for a punctured battery, and \$250 for a non-working Chromebook. ____ (PARENT INITIAL)

GENERAL RESPONSIBILITIES & CARE:

- I understand that the Chromebook is being monitored and filtered at all times.
- I understand that the act of searching, viewing, or participating in inappropriate and explicit sites and images, such as pornography, is a class B misdemeanor. ____ (STUDENT INITIAL)
- I understand that I am completely responsible for the device while it is checked out.
- I understand that I am not permitted to remove the device from the besd.net domain.
- I understand that I am not permitted to alter the design of the device. (No stickers or markings may be removed or added). **Removal of the serial number sticker from the bottom may result in a voided warranty and you financially responsible for the device.
- I understand the device should not be placed or stored in extreme temperatures.
- I understand the device should not be stored in wet or humid areas.
- I understand that I am not permitted to loan the device to anyone else.
- I agree to follow the Box Elder School District Acceptable Use Policy that can be found on the district website (besd.net).
- I agree to return the Chromebook, charger, and accessories in good working condition.
- I will not attempt to repair the device or make unauthorized modifications to the device.
- I understand that the district is not responsible for any viruses that may be transferred to or from my personal data storage mediums, and agree to use my best effort to prevent damage to the device that would render it inoperable.
